

MnCIFA e-Payment Portal User Manual

Revised: 1.30.2026

1. Purpose

This user manual provides step by step instructions for submitting payments through the e-Payment Portal. It is intended to help users successfully complete payments while ensuring accuracy, security, and compliance.

2. Who Should Use This Portal

Use the e-Payment Portal if you need to:

- a. Make a loan payment
- b. Pay an origination fee
- c. Pay another fee

3. Before You Begin

Before starting a payment, ensure you have:

- a. Your **loan number and invoice number**
- b. The **payment amount(s)**
- c. Your **contact information**
- d. **Bank account** information

Note: Incomplete or incorrect information may result in payment delays or processing errors.

4. Accessing the e-Payment Portal

- a. Navigate to [Client Payment Portal](#)
- b. Select **Project** then **Client Portal**.
- c. You will be redirected to the e-Payment intake screen.

5. Completing the Payment Intake Screen

On the intake screen, complete all required fields. These typically include:

6. Redirect to US Bank Secure Payment Portal

After selecting **Next**, you will be securely redirected to US Bank's secure payment portal website.

- The payment portal page is encrypted and secure.
- Do not refresh or close your browser during this step, otherwise you will have to resubmit your information again.

7. Submitting Your Payment

- Enter your bank account information.
